Net Sales Decreased 5.6% to \$29.9 Million; July 2009 Comparable Store Sales Decreased 16.8%

(NASDAQ: ZUMZ), a leading specialty retailer of action sports related apparel, footwear, equipment and accessories, today announced that total net sales for the four-week period ended August 1, 2009 decreased 5.6% to \$29.9 million, compared to \$31.7 million for the four-week period ended August 2, 2008. The company's comparable store sales decreased 16.8% for the four-week period, versus a comparable store sales decrease of 1.4% in the year ago period.
