Net Sales Increased 19.3% to \$56.1 Million; July 2013 Comparable Store Sales Increased 0.8%

The Company's comparable store sales increased 0.8% for the four-week period ended August 3, 2013 compared to a comparable store sales increase of 7.5% for the four-week period ended July 28, 2012.
