ZUMIEZ INC. REPORTS OCTOBER 2005 SALES RESULTS Net Sales Increased 29.5% to \$13.2 Million October 2005 Comparable Store Sales Increased 10.0%

Everett, WA – November 1, 2005 – Zumiez Inc. (NASDAQ: ZUMZ) a leading specialty retailer of action sports related apparel, footwear, equipment and accessories, today announced that total net sales for the four-week period ended October 29, 2005 increased 29.5% to \$13.2 million, compared to \$10.2 million for the four-week period ended October 30, 2004. The company's comparable store sales increased 10.0% for the past month, versus a comparable store sales increase of 11.9% in the year ago period.

For the thirteen-week period ended October 29, 2005, total net sales increased 26.7% to \$57.4 million, compared to \$45.3 million for the thirteen-week period ended October 30, 2004. The company's comparable store sales increased 9.8% for the third quarter of 2005, versus a comparable store sales increase of 9.0% in the year ago period.
